and concerned residents to discuss the problem of rubbish being dumped on the pavements outside of the two collection days which are Mondays and Thursdays. Some properties do not have basement cellars to store rubbish but it is the residents' responsibility to ensure that the pavements are kept clear. To report a problem, telephone 020 7361 3001.

A trial has been taking place of a small litter bin attached to a lamppost in the north east arm of the Square. It is emptied by the SITA street cleaning patrol and at weekends, those from Earl's Court Road empty it. Although we requested that a sign be attached to it to indicate that dog waste can be put into it, we have been advised by Streetline that this is not permissible. If the bin has not been emptied, please phone Streetline on 020 7361 3001.

Please note that collections do take place on a Monday when there is a Bank Holiday except the August Bank Holiday when the SITA crews are deployed to clear up after the Notting Hill Carnival.

#### Newsletter

Three newsletters were published during the year, the annual one in January, together with the revised History of Earl's Court Square, was delivered to all the households within the Earl's Court Square Conservation Area and we are grateful to those volunteers who helped



to deliver it to over 650 households. Two were published in June and September to paid up members of the Association only. We are grateful to Faron Sutaria for all the colour printing.

### Website

### **Properties**

This year scaffolding has been erected around the Square and redecoration or renovation work has been carried out at the following properties: numbers 4, 12, 20, 43-47, 48, 50, 53 and 55. Several years ago, ECSRA paid to have the house numbers painted onto the columns. Where there has been redecoration work, not all numbers were repainted and we would encourage the following properties to do this: 1, 4, 10, 18, 21, 23, 26 and 59. Work continued at No 23 for a basement excavation with similar work at No 21.

New front steps were installed at Nos. 11, 13, 17, 19 and 65.

### Traffic and Parking

Parking bays were suspended along the northern terrace of the Square associated with the temporary structure and skips for the work at numbers 21 and 23. During the summer, the road side structure was removed and the parking bays re-instated.

### Planning

We were pleased to learn that the appeal against the decision not to permit the redevelopment of the three garages in the north east arm of the Square was dismissed. We are very grateful to all those residents, and Cllr Linda Wade, for all their support.

Permission was sought to change the casement windows at No. 16 to sash and although ECSRA objected, permission was granted.

Two applications to erect a studio / cabin in the rear garden of No. 284 Earl's Court Road were dismissed.

ECSRA requested RBK&C to extend the policies covered by Article iv Directive 36 to the whole Conservation Area. Unfortunately, time and budget constraints have prevented this from being done.

### Filming in the Square



Filming for the television series, Whitechapel, took place outside Wetherby Mansions which was broadcast on ITV1 on 4 and 11 September. ECSRA received a donation of \$200 for the inconvenience caused with the south east arm being closed to cars and traffic for one day during April.

Filming also took place in Farnell Mews on 27 July.
